Christopher Ali

Pioneers Chair in Telecommunications and Professor of Telecommunications, Penn State University

Christopher Ali is the Pioneers Chair in Telecommunications and a professor of telecommunications in the Bellisario College of Communications at Penn State University. An acknowledged national expert on broadband deployment, policy, and planning, he is the author of the book *Farm Fresh Broadband: The Politics of Rural Connectivity*. Based on his expertise, Ali was called to testify on broadband funding and policy programs before the Senate Commerce Committee in 2021. He has also briefed members of the House Democrats Task Force on Rural Broadband, the New York State Blue Ribbon Commission on Reimagining New York, and the Federal Communications Commission, and he has presented before numerous state and county governments. His writing on broadband and communication policy has been published in the *New York Times*, *The Hill*, *Realtor Magazine*, the Law and Political Economy Project, *Digital Beat Magazine*, GovTech, Zócalo Public Square, *Washington Monthly*, *Columbia Journalism Review*, and *The Conversation*.

Ali has a Ph.D. in communication studies from the Annenberg School for Communication at the University of Pennsylvania.



Amanda Bergson-Shilcock

Senior Fellow, National Skills Coalition

Amanda Bergson-Shilcock is a senior fellow at National Skills Coalition, where she leads the organization's work on adult education and workforce policies to expand opportunities for U.S.-born and immigrant adults. Throughout her career, Bergson-Shilcock has worked with state and federal policymakers and skills advocates to develop policy solutions that address the challenges facing adult learners and jobseekers, including immigrant workers.

As a workforce development expert for more than a decade, Bergson-Shilcock has authored numerous publications and policy recommendations — on immigrant integration, workforce development, and adult education — that have helped educate policymakers, journalists, and the public and that inform public policy at the state and federal levels. Her policy expertise, insights, and commentary have been cited and published in local and national media outlets, including *Time*, *Fortune*, *BBC News*, *Inside Higher Ed*, *Politico*, *Business Insider*, the *Wall Street Journal*, *HR Dive*, and many others.

Prior to joining National Skills Coalition in 2015, Bergson-Shilcock served as vice president of policy and evaluation at the nonprofit Welcoming Center for New Pennsylvanians in Philadelphia. In that role, she led the Welcoming Center's policy and communications work on adult education, workforce, and economic development issues. She also served as policy and communications director for IMPRINT, a national coalition of nonprofit organizations focusing on the integration of immigrant professionals.

Bergson-Shilcock has a bachelor's degree from the University of Pennsylvania, where she studied American Civilization with an emphasis on minority populations. She is based in Philadelphia and Washington, D.C.

Harry Crissy

Regional Economic Resource Development Extension Agent, Penn State Extension

Harry Crissy is a regional economic resource development extension agent for Penn State Extension in northcentral Pennsylvania. He works with communities, individuals, and government bodies to identify and implement strategies conducive to both economic growth and environmental health. Crissy is a Leadership in Energy and Environmental Design (LEED) accredited professional (LEED Neighborhood Development, LEED for Homes, LEED Building Design and Construction) and has worked domestically and internationally on development projects aimed at improving the circumstances of populations from all economic strata.

His recent geospatial work includes efforts aimed at improving broadband access to unserved and underserved communities. Nathan Flood

President and CEO, KINBER

Nathan Flood was named KINBER's president and CEO in 2020, after serving as the organization's interim president and CEO and vice president overseeing daily operations and working closely with its board of directors. Under Flood's leadership and guidance, KINBER negotiated the sale of its assets; positioned itself for long-term financial sustainability; created Keystone REN LLC, a wholly owned subsidiary of KINBER focused on research and education networking; and provided input on state and national policy discussions around broadband.

Recently, Flood has provided the vision and direction for KINBER's strategic future focused on sustainable impacts to the Commonwealth in digital equity and inclusion, working with the broader community to have positive collaborations during this transformative period.

Prior to joining KINBER, he served as deputy secretary for the Pennsylvania Department of Conservation and Natural Resources and as chief of staff in the Pennsylvania Senate.

Flood's experience in economic and community development and technology includes service on the Warwick Township Planning Commission, the Pennsylvania State Transportation Innovation Council, and the Regional Advisory Committee for the Southwestern Pennsylvania Connected initiative.

He currently serves on the boards of Keystone REN LLC; The Quilt; ELA Group, Inc.; and an engineering ESOP, as well as serving as a past chair of the Pennsylvania Integrated Library System and as the current chair of the Natural Streams Foundation.

In addition to his leadership roles in and out of KINBER, Flood is active in his community, having served on his local planning commission, volunteered with the Masonic Center of Lancaster County, and mentored his daughter's youth soccer team and dance studio.



Rob Fry

General Field Representative, U.S. Department of Agriculture

Rob Fry currently serves as the general field representative for the Rural Utility Service, Telecom Division of the U.S. Department of Agriculture (USDA), covering New York, New Jersey, and Pennsylvania, as well as all of New England, for the past five years. Fry has been with USDA Rural Development for 14 years, serving as a management and program analyst, loan and grant analyst, and community programs specialist.

Prior to joining Rural Development, Fry was employed in the private sector for 20 years in commercial lending. He is a graduate of King's College in Wilkes Barre, PA, with a degree in marketing.



Dave Gibbons

Founder, Black Bear Fiber

Dave Gibbons is the founder of Black Bear Fiber and the owner of Centre WISP, a fiber and wireless internet service provider (ISP) that provides service primarily to underserved areas in central Pennsylvania. A lifelong entrepreneur, Gibbons has been involved in building and operating small ISPs since 2015. Centre WISP has grown from serving one small wireless broadband territory in 2015 to providing wireless service through many dozens of towers across seven counties, and gigabit fiber service to thousands of customers, today.

Aadil Ginwala

Senior Policy Advisor, University of Pittsburgh

Aadil Ginwala is senior policy advisor to the chief information officer at the University of Pittsburgh. His focus is the economic growth and social benefit potential possible from universal affordable high-speed internet access, especially in the context of ensuring next-generation, cutting-edge speeds and affordability for the city of Pittsburgh, the broader western Pennsylvania region, and the Commonwealth as a whole.

Previously, Ginwala served as chief of staff of the National Telecommunications and Information Administration (NTIA) in the Department of Commerce as a political appointee of President Biden and Secretary Raimondo. He was a leader of the agency when it was charged, in the Bipartisan Infrastructure Law, with distributing \$46 billion to ensure affordable high-speed internet for every American and was instrumental in designing the rules for the Broadband Equity, Access, and Deployment Program.

Prior to joining NTIA, Ginwala served in the Obama White House from 2015 until the end of the administration; while there, he worked on the launch of the \$400 million Advanced Wireless Research Initiative, a public-private partnership focused on developing technologies for 5G and beyond that is now administered by the National Science Foundation as the Platforms for Advanced Wireless Research. He also helped organize interagency work to finalize a northeastern Pennsylvania regulation to streamline deployment of broadband through federal lands as well as a program comment for historical preservation by the Advisory Council on Historic Preservation. In addition, Ginwala worked closely with the National Economic Council and other White House agencies on tribal and rural broadband and attempts to close the digital divide and homework gap.

Between leaving the Obama administration and joining NTIA, Ginwala was the founder and chief executive officer of an artificial intelligence startup in the healthcare space in Pittsburgh, PA.

Ginwala has a law degree and bachelor's degree from Harvard Law School and Harvard University, respectively, and is a proud alumnus of the Peace Corps.



Christine Hallquist

Executive Director, Vermont Community Broadband Board

Christine Hallquist is the executive director of the Vermont Community Broadband Board and is charged with getting every Vermont address connected to fiber optic internet, making it affordable and maximizing the position social impact of those investments. Hallquist started her career with Digital Equipment Corporation, working in power systems design and manufacturing. She then started consulting in business process redesign and worked with companies such as Honda to optimize the entire process of new product development. Later, she became chief executive officer of Vermont Electric Cooperative (VEC), taking the company from bankruptcy to being an A+ rated utility.

The VEC board of directors was also interested in providing broadband services, and Hallquist worked with many different technologies, including radio, spread spectrum (power line communications), satellite, and cellular.

Biographies

In 2018, she became Vermont's Democratic candidate for governor.

In early 2019, Hallquist formed a Canadian joint-venture company to develop a porous silicon battery that would provide three times the energy density of lithium ion.



Stephen Herzenberg

Executive Director, Keystone Research Center, and Codirector, Reimagine Appalachia

Stephen Herzenberg has been executive director of Keystone Research Center (KRC) since December 1995. He is also the codirector of the Reimagine Appalachia campaign, for which he has coauthored an introductory overview on broadband and a brief on principles for state broadband policies. KRC has helped shape and implement Pennsylvania workforce policies related to industry partnerships and apprenticeship for over two decades. Herzenberg has published widely on economic and labor market issues and also on the construction industry, including two pieces in 2023. His recent writings for national audiences include recommendations to the Biden administration on how to achieve progress on Sustainable Development Goal #8; a chapter in *The Many Futures of Work* on how the labor movement might grow again; and the KRC 2019 report, *Towards an AI Economy That Works for All*. He is also the coauthor of *New Rules for a New Economy: Employment and Opportunity in Postindustrial America*.

Herzenberg has a Ph.D. in economics from MIT.



Philip Jones

Community Engagement Associate, Federal Reserve Bank of Philadelphia

Philip Jones is a community engagement associate in the Philadelphia Fed's Community Development and Regional Outreach Department. He focuses on building and supporting cross-sector partnerships to advance equitable solutions to a region or community's economic challenges.

Jones is passionate about ensuring that residents have access to safe and affordable homes. Before joining the Bank, he worked for the Fair Housing Rights Center in southeastern Pennsylvania, where he advocated for equal access to housing opportunities for all people. It was here that he learned about the inequities that exist in securing credit or home loans in marginalized communities and how building awareness of available programs and services within these communities was key to helping to address these challenges.

Through his work as the director of legislative affairs for Pennsylvania State Representative Stephen Kinsey, Jones also gained experience building relationships and working with leaders and community partners across the state to address key issues. He organized the first-ever legislative policy hearing at a Pennsylvania state correctional facility focused on the social benefits and economic advantages of granting compassionate release of the geriatric incarcerated population.

Kyle Kopko

Executive Director, Center for Rural Pennsylvania

Kyle C. Kopko is the executive director of the Center for Rural Pennsylvania. He joined the Center in July 2020. Prior to joining the Center, Kopko served as associate dean of institutional effectiveness, research, and planning and associate professor of political science at Elizabethtown College. Kopko has authored or coauthored more than 50 publications, including two university press books. His research has received national and international media attention in outlets such as the *Wall Street Journal*, the *Washington Post*, the *New York Times*, *CNN*, the Canadian Broadcasting Corporation, and Fox News Channel.

Sascha Meinrath

Palmer Chair in Telecommunications, Penn State University

Sascha Meinrath is the Palmer Chair in Telecommunications at Penn State University and director of X-Lab, an innovative think tank focusing on the intersection of vanguard technologies and public policy. He was previously vice president of the New America Foundation, where he founded the Open Technology Institute in 2008 and built it into one of the largest public interest tech policy organizations in Washington, D.C. He also founded the Commotion Wireless Project, which works around the globe to strengthen communities by providing tools to build their own local communications infrastructures, and cofounded Measurement Lab, a global online platform for researchers to deploy internet measurement tools that empower the public and key decision-makers with useful information about broadband connectivity.
