David R. Hunsicker has been the President and Chief Executive Officer of New Tripoli Bank for the past 18 years and has been an employee of the bank for 43 years. New Tripoli Bank, located in the Lehigh Valley, is a \$390 million-asset community bank with two branches.

In 2004, Hunsicker was appointed to Governor Edward Rendell's Working-Families Task Force, which was charged with "identifying strategies and programs to build incomes and assets for working families, promoting financial education and literacy, and protecting working families from abusive financial services."

Hunsicker was elected to the board of directors of the Philadelphia Federal Reserve Bank in 2013. He had been a member of the Philadelphia Federal Reserve Audit Committee from 2013 to 2015, serving as deputy chairman in 2014 and chairman in 2015. He became a member of the Nominating & Governance Committee in 2015.
