**Mergers, Closures, and Institutional Changes as of 2018:Q1**

- 1/31/2018 - Sun Bancorp, Inc., and its subsidiary Sun National Bank, were acquired by OceanFirst Financial Corp. OceanFirst Financial Corp. converted to a bank holding company due to the conversion of OceanFirst Bank to a national commercial bank from a federal savings bank. Sun National Bank will function as a division of OceanFirst Bank NA until the integration of operating systems, which is expected to be completed in June.
- 2/12/2018 - Malvern Federal Savings Bank converted to a national bank and will operate as Malvern Bank NA. Additionally, the bank's parent, Malvern Bancorp Inc., will be registered as a bank holding company.
- 3/1/2018 - Liberty Bell Bank was acquired by Delmar Bancorp. The bank was merged into the bank subsidiary, Bank of Delmarva.
- 3/26/2018 - Wavel Financial Services (MHC), and its subsidiary Wavel Bank, were acquired by Spencer Savings Bank SLA. Wavel Bank will function as a division of Spencer Savings Bank until the integration of operating systems, which is expected to be completed in July.

- 4/1/2018 - Clifton Bancorp, Inc., and its subsidiary Clifton Savings Bank, were acquired by Kearney Financial Corp. Clifton Savings Bank was merged into Kearney's bank subsidiary, Kearney Bank.
- 5/1/2018 - Liverpool Community Bank was acquired by Juniata Valley Financial Corp. Liverpool Community Bank merged into the bank subsidiary, Juniata Valley Bank.
- 5/1/2018 - Delanco Bancorp, Inc., and its subsidiary Delanco Federal Savings Bank, were acquired by First Bank. Delanco Federal Savings was merged into First Bank.
- 5/21/2018 - Amalgamated Bank completed its acquisition of New Resource Bancorp (San Francisco, CA), and its subsidiary bank New Resource Bank. New Resource Bank was merged into Amalgamated Bank.

- 8/24/2018 - Meridian Corp. was established and became the parent company of Meridian Bank.
- 9/8/2018 - Freehold Savings Bank converted to a New Jersey-chartered capital stock savings bank from a federal capital stock savings bank.

- 10/13/2018 - Fulton Financial subsidiaries Swineford National Bank and FNB Bank NA were merged into Fulton Bank NA .
- 10/17/2018 - Metuchen MHC, and its subsidiary Metuchen Saving Bank, merged into MB Mutual Holding Co. Metuchen Savings Bank was merged into Manasquan Bank.
