Mergers, Closures, and Institutional Changes as of 2015:Q1

1/1/2015 – Valley Green Bank was acquired by Univest Corp. of Pennsylvania and was merged into Univest Corp.'s subsidiary, Univest Bank and Trust Co.

1/1/2015 – Continental Bank Holdings, Inc., and its subsidiary Continental Bank, were acquired by Bryn Mawr Bank Corp. All Continental Bank branches will continue to operate under the Continental Bank name until the completion of the banking system conversion, which is scheduled for September 2015.

1/12/2015 – Beneficial Bancorp Inc. completed the conversion of Beneficial Mutual Savings Bank (MHC) from the mutual holding company to the stock holding company form of organization and converted to a bank holding company. As a result, Beneficial Bancorp Inc. is now the holding company for the bank, and Beneficial Savings Bank MHC and Beneficial Mutual Bancorp Inc. (MHC) have ceased to exist.

3/2/2015 – Phoenix Bancorp, and its subsidiary Miners Bank, were acquired by Mid Penn Bancorp, Inc. Phoenix Bancorp merged into Mid Penn Bancorp effective March 1. Concurrently with the combination of the two companies, Miners Bank was merged into Mid Penn Bank and now operates as Miners Bank, a division of Mid Penn Bank.

3/4/2015 – Integrity Bancshares Inc., and its subsidiary, Integrity Bank, were acquired by S&T Bancorp, Inc. Integrity Bank remains a subsidiary of S&T Bancorp, Inc. and will merge into S&T's subsidiary, S&T Bank, as soon as practicable. S&T expects the bank merger as well as the information technology and data processing systems conversion to be completed in the second quarter.

3/28/2015 – FNB Financial Corp., and its subsidiary, First National Bank of Minersville, were acquired by GNB Financial Services, Inc. First National Bank of Minersville was merged into GNB's subsidiary, Gratz Bank.

Mergers, Closures, and Institutional Changes as of 2015:Q2

4/1/2015 – Colonial Financial Services, and its subsidiary Colonial Bank FSB, were acquired by Cape Bancorp, Inc. Colonial Bank FSB was merged into Cape Bancorp Inc.'s subsidiary, Cape Bank.

4/28/2015 – CMS Bancorp, Inc., and its subsidiary CMS Bank, were acquired by Putnam County Savings Bank. CMS Bank was merged into Putnam County Savings Bank.

7/31/2015 – Colonial American Bank FSB, and its subsidiary Colonial American Bank, were acquired by OceanFirst Financial. Colonial American Bank was merged into Colonial American Bank FSB's subsidiary, OceanFirst Bank.

As a result of mutual holding company conversions to stock companies, Kearney Financial Corp. and Metuchen BC have updated ID RSSD numbers. They are highlighted on the SLHC tab.

Mergers, Closures, and Institutional Changes as of 2015:Q3

7/27/2015 – Milestone Bank changed its name to Covenant Bank.

7/31/2015 – Susquehanna Bancshares, Inc., and its subsidiary Susquehanna Bank, were acquired by BB&T Corporation. Susquehanna Bank was merged into BB&T's commercial bank subsidiary, BB&T.

8/1/2015 – FSB Mutual Holdings, Inc., and its subsidiary First Savings Bank of Perkasie, merged with First Federal Savings and Loan Association of Bucks County. After the merger, the institution changed its name to Penn Community Mutual Holdings Inc., with the bank subsidiary known as Penn Community Bank.

Mergers, Closures, and Institutional Changes as of 2015:Q4

During 2015Q4, Cape Bancorp converted to a bank holding company from a savings and loan holding company.

10/9/2015 – Alliance Bancorp Inc., and its subsidiary Alliance Bank, were acquired by WSFS Financial Corp (WSFS). Alliance Bank was merged into WSFS's commercial bank subsidiary, WSFS FSB.

11/1/2015 – Hudson City Bancorp Inc. dissolved when its subsidiary bank was acquired by M&T Bank Corporation.

12/1/2015 – FNBPA Bancorp Inc., and its subsidiary First National Bank of Port Allegany (FNBPA), was acquired by Juniata Valley Financial Corp (JVFC). FNBPA was merged into JVFC's commercial bank subsidiary, Juniata Valley Bank.

12/1/2015 – College Savings Bank was acquired by NexBank Capital Inc. College Savings Bank will remain a division of NexBank Capital Inc.'s subsidiary, NexBank SSB.

12/4/2015 – Eagle National Bancorp Inc., and its subsidiary Eagle National Bank, were acquired by ESSA Bancorp Inc. (ESSA). Eagle National Bank was merged into ESSA's commercial bank subsidiary, ESSA Bank & Trust.

12/7/2015 – Oneida Financial Corp. (Oneida), and its subsidiaries Oneida Savings Bank and State Bank of Chittenango, was acquired by Community Bank System Inc. Oneida Savings Bank and State Bank of Chittenango were merged into Community Bank System Inc.'s commercial bank subsidiary, Community Bank NA.

12/11/2015 – First Nation Bank of Fredericksburg (FNB Fredericksburg) was acquired by Citizens Financial Services Inc. FNB Fredericksburg was merged into Citizens Financial Services Inc.'s commercial bank subsidiary, First Citizens Community Bank.

Mergers, Closures, and Institutional Changes as of 2016:Q1

2016Q1 – Covenant Financial Inc., the holding company for Covenant Bank, was established.

2016Q1 – Atlantic Community Bancshares Inc., the holding company for Atlantic Community Bankers Bank, was established.

1/8/2016 – Hopewell Valley Community Bank (HVCB) was acquired by Northfield Bancorp. HVCB was merged into Northfield Bancorp's commercial bank subsidiary, Northfield Bank.

2/16/2016 – Metro Bancorp Inc. (Metro), and its subsidiary Metro Bank, were acquired by F.N.B. Corporation (FNBC). Metro was merged into FNBC's commercial bank subsidiary, First National Bank of Pennsylvania.

2/24/2016 – West Milton Bancorp Inc. changed its corporate name to Susquehanna Community Financial Inc. West Milton State Bank, the bank subsidiary of Susquehanna Community Financial, will retain its name.

3/1/2016 – Cresson Community Bank was acquired by C&G Savings Bank. Post-merger, the name of the combined banks changed to PennCrest Bank.

Mergers, Closures, and Institutional Changes as of 2016:Q2

2016Q2 - There were three mutual conversions to holding companies during the second quarter, including:
Lincon Park BC, Riverbank Financial SHC, and William Penn BC

4/1/2016 – National Penn Bancorp, Inc., and its subsidiary National Penn Bank, were acquired by BB&T Corporation. National Penn Bank was merged into BB&T's commercial bank subsidiary, BB&T.

4/8/2016 – Conestoga Bank was acquired by Beneficial Financial Corp. Conestoga Bank was merged into Beneficial's bank subsidiary, Beneficial Savings Bank.

5/2/2016 - Cape Bancorp, Inc., and its subsidiary bank Cape Bank, were acquired by OceanFirst Financial Corporation. Cape Bank was merged into OceanFirst's commercial bank subsidiary, OceanFirst Bank.

5/6/2016 - The PADOB seized King of Prussia, Pa.-based First CornerStone Bank and named the FDIC receiver. The FDIC entered into a purchase and assumption agreement with Raleigh, N.C.-based First Citizens BancShares Inc. unit First-Citizens Bank & Trust Co. (\$32.05 billion) to acquire all of the deposits of the failed bank as well as essentially all of its assets.
